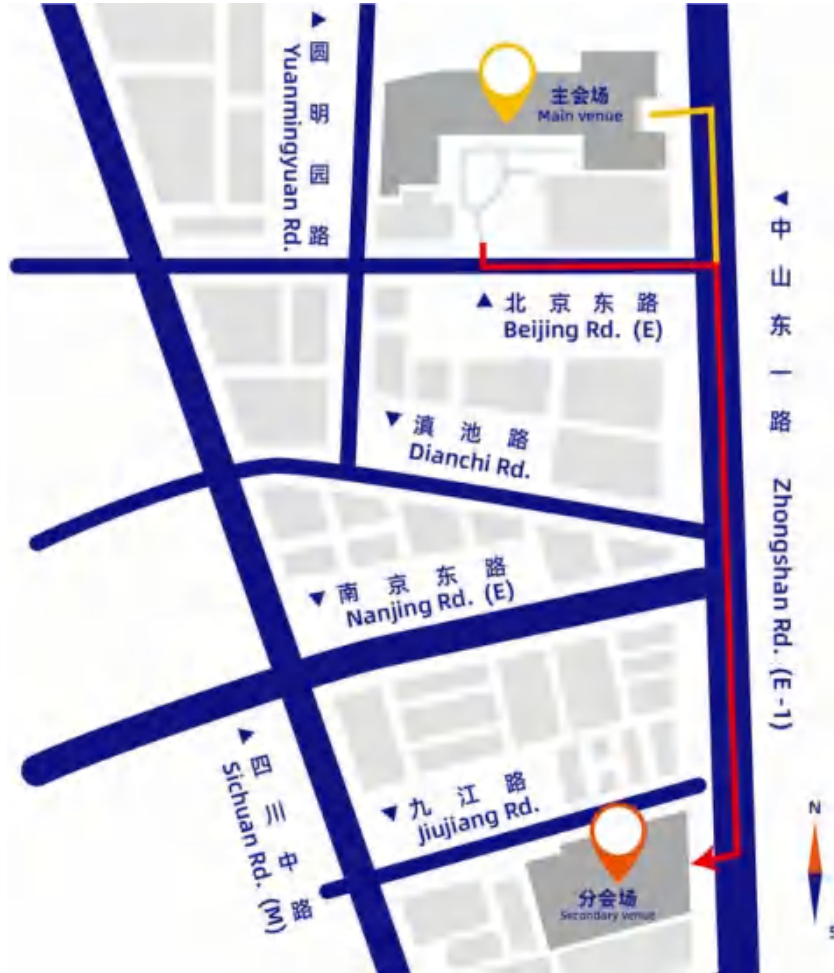

2024年，世界继续经历深远的变化，全球经济面临高度的不确定性。地缘政治冲突，贸易保护主义抬头，国际贸易体系面临碎片化挑战。主要央行货币政策正尝试转向，但去通胀的最后一公里未必是坦途。人工智能技术革命正蓄势待发，但也蕴含着颠覆性的风险。能源危机、气候变化、人口老龄化等问题仍待解决，全球经济可持续发展的挑战与机遇并存。与此同时，多场重要选举或将带来全球政治格局调整，也为全球治理带来了新的不确定性。

为应对变局世界中的新挑战，探寻全球合作与发展的新路径，第六届“外滩金融峰会”于2024年9月5-7日在上海召开。峰会由中国金融四十人论坛（CF40）与中国国际经济交流中心（CCIEE）联合主办，广邀全球财经政要、机构高管与学界领袖齐聚外滩，通过高水平的思想碰撞与观点交锋，分享真知灼见，以对话推动共识，以共识推动合作，携手共建开放型世界经济。

第六届外滩金融峰会持续聚焦国际金融、绿色金融、科技金融、数字金融四大议题，坚持“国际化”、“专业化”定位，为上海建成具有全球重要影响力的国际金融中心，为中国作为建设性力量参与国际治理，为国际社会消弭分歧、增进互信、凝聚共识，贡献价值与力量。

In 2024, the world continues to navigate profound changes and uncertainties, seeing challenges from escalating geopolitical tensions, rising protectionism, and geoeconomic fragmentation. For the global economy, the last mile of inflation fight is proving tougher as major central banks endeavor to manage policy shifts. In the realm of technology, the rapid advancement in artificial intelligence harbors both immense promise and potential peril. Meanwhile, persistent issues such as energy crises, climate change, and population ageing continue to present both challenges and opportunities for the world's sustainable development. Against this backdrop, multiple important elections around the globe could reshape the global political landscape, introducing further complexities into global governance.

As an annual convening of leading minds from around the world, the Bund Summit seeks to explore trends, generate dialogues, build consensus, and foster partnerships towards a more resilient and sustainable future. This year, the discussions will cover key issues such as global economy, international finance, green development, and financial technology.

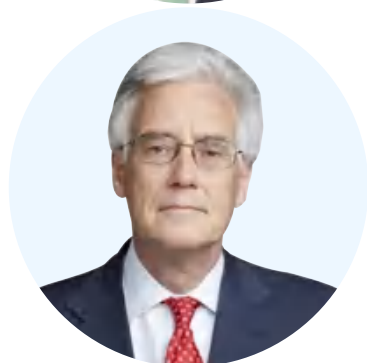
